#### **Course Description**

This course explores architecture, urbanism and architectural theory from 1750 to 1900. Issues such as Enlightenment philosophy, industrialization, urbanization, nationalism, revolution and technological innovation are considered as they bear on the theory and practice of architecture in a world that was rapidly modernizing.

#### Course Goals:

The following course goals articulate the general objectives and purpose of this course

- 1. Students will learn about the major historical forces that shaped the course of early modern architecture.
- 2. Students will strengthen their awareness of architectural terminology, typology, technology, materials



and symbolism.

3. Students will strengthen their ability to discuss, analyze and interpret works of architecture and urban design.

1. Students will identify and discuss the major figures and works of architecture and urbanism in this period.
