**OFFICIAL COURSE DESCRIPTION:**

In this introductory course on the scientific study of behavior, you will learn about the historical roots of contemporary psychology and research methods of analyzing data. You will study the anatomy and physiology of the nervous system and factors which mobilize and direct behavior (e.g., motivation & emotion). Perception, learning, and cognition will be introduced as ways in which knowledge is gained through the senses, organized and utilized. You will learn about personality and psychological disorders. The interpretation of social situations will explain how one's behavior is influenced by others.

**COURSE GOALS AND LEARNING OBJECTIVES:**

**Course Objectives**

- Understand empirical reasoning and the scientific method.
- Appreciate how psychologists rely on statistics to interpret research findings.
- Learn about various methods of data collection.
- Identify structures of the brain and nervous system, and how they regulate behavior.
- Identify basic principles of classical and operant conditioning.
- Understand how information is encoded and retrieved from memory.
- Identify obstacles that need to be overcome in solving problems.
- Understand heuristics involved with decision making.
- Appreciate the reliability and validity of intelligence testing.
- Understand developmental stages of personality and cognition.
- Understand altered states of consciousness including sleep, drugs and hypnosis.
- Learn about symptoms, progression, and treatment of psychological disorders.
- Understand how behavior is influenced by the presence of other people.
- Develop critical thinking, problem-solving skills & communication skills.
